COVID-19 Update

CDC Recommendations for Fully Vaccinated People

Summary of Recent Changes as of July 27th

- Updated information for fully vaccinated people given new evidence on the B.1.617.2 (Delta) variant currently circulating in the United States.
- Added a recommendation for fully vaccinated people to wear a mask in public indoor settings in areas of **substantial or high transmission**.
- Added information that fully vaccinated people might choose to wear a mask regardless of the level of transmission, particularly if they are immunocompromised or at **increased risk for severe disease** from COVID-19, or if they have someone in their household who is immunocompromised, at increased risk of severe disease or not fully vaccinated.
- Added a recommendation for fully vaccinated people who have a known exposure to someone with suspected or confirmed COVID-19 to be tested 3-

5 days after exposure, and to wear a mask in public indoor settings for 14 days or until they receive a negative test result.

Battery maker **SES Holdings Pte** has agreed to go public by merging with Ivanhoe Capital Acquisition Corp. in a deal that will value the combined company at about \$3.6 billion. Singapore-based SES, which makes hybrid lithium-metal rechargeable batteries for electric vehicles, currently has prototypes almost ready for Hyundai and General Motors, according to Qichao, Hu, founder and chief executive officer of SES, and the partnership with nickel-producer Ivanhoe will be highly strategic.
